
We have finally figured out a way to put aerators/bubblers in all three ponds. The first pond, as you come into The Estuary already has aerators. The Blue Crane pond is partially finished. Unfortunately as in many other instances COVID has drastically slowed the permits and inspections, but we did find a way. We have also found a way to put aerators in the Albatross pond, and will proceed with that process in the near future.

NEW WATERING GUIDELINES

The construction in south Hillsborough County seems to have resulted in a water shortage. There is a temporary one day a week with strict morning and evening irrigation hours from January 4, 2021 to December 31, 2022. Below is the schedule:

DAYS:

MONDAY—Addresses ending in 0 or 1

TUESDAY—Addresses ending in 2 or 3

WEDNESDAY—Addresses ending in 4 or 5

THURSDAY—Addresses ending in 6 or 7

FRIDAY—Addresses ending in 8 or 9

SATURDAY—Locations with no address and locations with mixed addresses (such as office complexes and shopping centers)

SUNDAY—NO WATERING

TIMES

All watering must be done either between 8:30 AM and noon OR between 6 PM and midnight, and only once on your designated day.
